E. Nursing Education

1. Education Sub Committee -

2. Clinical Placements – challenges with clinical placements –Ms. Meyer attended a meeting hosted by Representative Cody, Representative Slatter and Representative Enternan on clinical placements. Representative Cody requested the NCQAC explore standardized clinical hours. Ms. Meyer and Dr. Babbo will schedule an interested parties meeting in December.

Dr. Babbo reported on comments from the nursing education programs related to the challenges from unvaccinated students and the requirement to complete clinical experiences. Unvaccinated students are not able to complete the clinical portion due to facility requirements for all nursing students to be vaccinated. Nursing Program Covid Guidance Winter/Spring – allows for 100% simulation for mental health, OB & Peds. Programs have different of clinical hours as the regulations are a minimum amount of clinical hours.

VI. Education Session Cultivating Joy: Improving Nurse Resilience Through Use of a Practice Playbook – Diana Meyer, DNP, RN, NEA-BC, FAEN

Dr. Diana Meyer, retired as the senior director of a team of researchers at St. Luke's Health System, Idaho. Dr. Meyer presented study findings on nurse resilience. Nurse resilience, responsibilities in healthcare systems, and individual actions were described as well as strategies to improve nurse resilience. The research described the nurse resilience outcomes related to use of the strategies.

A. Nursing Education

- Presentation-Nursing Education During Covid Direct Clinical/Simulation Dr. Mary Baroni presented information on the average clinical placement hours and use of simulation by nursing education programs at Council of Nurse Educators of Washington State (CNEWS). Dr. Baroni gave the presentation for NCQAC. Dr. Baroni and Dr. Babbo also presented the assignment to explore standardizing clinical placement hours.

B. Nursing Assistants

- 2. Update on Testing Progress and Curriculum Work: working through backlog of nursing assistants who are registered but need to be certified. Approximately 6000 have taken the written portion of the certification examination, 5000 have taken skills

portion of the certification examination. Pass rate average is 70%. We anticipate 5000 nursing assistants to complete the written and skills portions of the examination within the next two months.

Testing changes: new test vendor who will be fully phased in by January 31, 2022. 3.Developing the LPN Apprenticeship Summit – The summit was held on October 22 with excellent participation. The summit focused on the development of the LPN apprenticeship programs and process for nursing programs to apply.

X. 2:45 PM – 3:15 PM HELMS Update – Marcus Bailey, Paula Meyer -DISCUSSION/ACTION

Health Systems Quality Assurance (HSQA), with the NCQAC, Washington Medical Commission and the Chiropractic Care Quality Assurance Commission, is replacing the current database with a new database, the Health Enforcement and Licensing Management System (HELMS). At the September meeting, Christie Spice, HSQA acting assistant secretary, announced the decision package for additional funding for the HELMS project. Ms. Meyer gave the presentation for Mr. Bailey

Issues of poor performance in regard to subcontractor vendor for integration services. The issues were brought to the attention of the main contractor, Carasoft. Carasoft removed the integration subcontractor. Other options are being explored.
