Draft Minutes:

CSPSC agreed to move the December 1, 2023, draft minutes to the March WABON business meeting. CSPSC members recommend the WABON approve the minutes.

Old Business:

Informed Consent Advisory Opinion – Shana provided an update and announced that the first workshops provided good recommendations from the public and partners. Additional workshops will be scheduled. Notification will be sent to the public through GovDelivery distribution list and an invitation to key partners.

Registered Nurse (RN) Delegation: Commonly Asked Questions (CAQs) – Debbie provided an update about the CAQ drafts related to RN delegation. Staff continue to refine these documents.

COVID-19 Screening Workshop Update – Shana provided an update about the questions and challenges with the COVID-19 screening CAQs. Significant changes have emerged since the emergency waiver was lifted last May. Some of the challenges are with the authority of the RN to delegate. Facilities may not have an RN and sufficient staff available to continue testing, or they might have unlicensed assistive personnel (UAP) available to perform testing, but do not have an RN to delegate to the UAP. Another issue is whether an order is required from an authorized practitioner to do CLIA-waived COVD-19 testing. Meetings were held with concerned parties, and email follow-up was sent to concerned parties to communicate next steps.

Quality Improvement/CSPSC's Prioritization Work Update: Shana provided an update about the work on the prioritization model for CSPSC activities. The model is under development and will be tested shortly. This work is guided by Diana Meyer. Ms. Meyer explained that this will allow us to be timely about completing requests with the resources available.

New Business:

Multistate License Implementation – Ms. Carlson previewed the website and the resources available to self-educate us as we address lots of questions that are coming in. There are eleven states that are not in the Nurse Licensure Compact (NLC).

Category: Corona Virus-19 (COVID-19) Testing

Registered Nurse (RN) Scope of Practice: COVID-19 Testing

Can the registered nurse (RN) perform a Clinical Laboratory Improvement Amendments (CLIA)-waived Point-of-Care (POC) COVID-19 test without an order or standing order from an authorized health care practitioner?

Yes.

The RN may perform a CLIA-waived POC COVID-19 antigen test based on the nursing process without an order or standing order from an <u>authorized health care practitioner</u> because a CLIA-waived test is considered a screening test and not a diagnostic test. Employers/facilities may have policies requiring an order for these tests and other requirements, such as completion of competency assessment, and quality control testing. The employer/facility must have a CLIA-waived certification:

Can the registered nurse (RN) perform a Point-of-Care Test (POC) polymerase chain reaction (PCR) COVID-19 test without an order or standing order from an <u>authorized health</u> care practitioner?

Yes. An order or standing order from an <u>authorized health care practitioner</u> is required for the RN to perform a POC PCR COVID-19 test. A PCR test is considered the "gold standard" for COVID-19 tests as they are more likely to detect the virus than antigen tests. A PCR is regarded as a diagnostic test instead of a screening test.

Category: Corona Virus-19 (COVID-19) Testing

Licensed Practical Nurse (LPN) Scope of Practice: COVID-19 Testing

Can the licensed practice nurse (LPN) perform a Clinical Laboratory Improvement Amendments (CLIA)-waived Point-of-Care (POC) COVID-19 test without an order or standing order from an authorized health care practitioner?

No. The LPN does not practice independently. The LPN may perform a CLIA-waived POC COVID-19 antigen test under the direction/orders and supervision of the RN or <u>authorized health care practitioner</u> in any setting. The LPN may follow <u>standing orders</u>. Employers/facilityiesmay have policies that require an order for these tests and other requirements (e.g., competency assessment completion and quality control testing). The employer/facility must have a CLIA-waived certification (Citation):

Can the licensed practical nurse (LPN) perform a Point-of-Care Test (POC) polymerase chain reaction (PCR) COVID-19 test without an order or standing order from an <u>authorized health</u> care practitioner?

No. The LPN does not practice independently. The LPN may perform a CLIA-waived POC COVID-19 antigen test based on the direction/orders and supervision of the RN or <u>authorized health care practitioner</u>. The LPN may follow standing orders.

Is the licensed practical nurse (LPN) allowed to delegate COVID-19 testing to the nursing assistant-registered/nursing assistance-certified (NA-R/NA-C), home care aide-certified (HCA-C), medical assistant-registered/medical assistant/certified (MA-R/MA-C) or non-credentialed staffin any setting, the LPN cannot delegate tasks to the NA-R/NA-C, HCA-C, MA-R/MA-C, or non-credentialed staff.

Category: Corona Virus-19 (COVID-19) Testing

Registered Nurse (RN) Delegation of COVID-19 Testing in Public and Private School Settings, Kindergarten-Twelve (K-12)

Can the school registered nurse (RN) delegate to the nursing assistant-registered/nursing assistant-certified (NA-R/NA-C), medical assistant-registered/medical-assistant-certified (MA-R/MA-C), or non-credentialed staff to perform Point-of-Care (POC) Clinical Laboratory Improvement Amendments (CLIA)-waived COVID-19 testing or POC polymerase chain reaction (PCR) COVID-19 testing?

Yes. COVID-19 testing requires RN delegation in the school setting to perform CLIA-waived antigen test or PCR COVID-19 test in public and private schools, kindergarten-twelve (K-12) grades. Based on the nursing assessment, theRN may delegate a POC COVID-19 antigen test

without an order or standing order from an <u>authorized health care practitioner</u>, because A CLIA-waived test is considered a screening test, not a diagnostic test. An order or standing order from an <u>authorized health care practitioner</u> is required for the RN to delegate a POC PCR test. Schools may have policies that require an order for these tests and other requirements (e.g., competency assessment completion and quality control testing). The school or school district must have a CLIA-waived certification to make that determination, take that determination.

t Is registered nurse (RN) delegation required if a student self-tests for a COVID-19-waived test using a Clinical Laboratory Improvement Amendments (CLIA)-waived test in public and private schools, kindergarten-twelve (K-12) grades?

No. RN delegation is not required if a student does a self-test using a COVID-19 CLIA-waived test. The RN can direct school staff to instruct the student to do the self-test following the COVID-19 test kit instructions, including observing the student doing a self-test, and reporting the results to the school RN. The school or school district should have policies and procedures for students to perform self-testing.

Can the registered nurse (RN) who volunteers at the school perform Point of Care (POC) Clinical Laboratory Improvement Amendments (CLIA)-waived COVID-19 or (POC) polymerase chain reaction (PCR) COVID-19 test in public and private schools, kindergarten-twelve (K-12) grades?

Perhaps. The RN performing POC CLIA-waived or PCR COVID-19 tests to students in public and private schools, K-12 grades, must be employed or have a formal agreement/contract with the school or school district.

Can the registered nurse (RN) who works for a private company that has the Medical Test Site Waiver perform Clinical Laboratory Improvement Amendments (CLIA)-waived COVID-19 or POC polymerase chain reaction (PCR) COVID-19 tests in public and private schools, kindergarten-twelve (K-12) grades?

Maybe. The RN working for a private company may perform POC CLIA-waived or PCR COVID-19 tests on students in public and private schools, K-12 grades if there is a formal agreement/contract agreement/contract with the school or school district.

What should schools do if they don't have a registered nurse (RN) employed or contracted with the school to perform COVID-19 tests?

For schools without an RN, an option may be to offer take-home COVID-19 rapid antigen tests or have parents/legal guardians test the student.. Staff member can hand a rapid antigen COVID-19 tests to students/parents and staff for individual or self-administered use.

Can the registered nurse (RN) who works for a county health department or the Washington State Department of Health (WA DOH) perform Point of Care (POC) Clinical Laboratory Improvement Amendments (CLIA)-waived COVID-19 or (POC) polymerase chain reaction (PCR) COVID-19 tests in public and private schools, and kindergarten-twelve (K-12) grades? Maybe. The RN working for a county health department or the WA DOH may perform POC CLIA-waived COVID-19 or PCR tests to students in public and private schools, K-12 grades if there is a formal agreement/contract agreement/contract with the school or school district.

Can the parent or legal guardian sign a form to allow a non-credentialed school staff person to perform a Point of Care (POC) Clinical Laboratory Improvement Amendments (CLIA)-waived COVID-19 test or a Point of Care polymerase chain reaction (PCR) COVID-19 test without registered nurse (RN) delegation through the process of in loco parentis (in place of the parent) in public and private schools, kindergarten-twelve (K-12) grades?

No. The school laws do not allow a parent or legal guardian to sign a form to allow a non-credentialed school staff person to perform a CLIA-waived COVID-19 test.

Can a student's parent or legal guardian perform a CLIA-waived test in public and private schools, kindergarten-twelve (K-12) grades?

Yes. The laws and rules do not prohibit a parent or legal guardian from performing a CLIA-waived test at the school. This activity would be like testing at home.

Can the registered nurse (RN) delegate to non-credentialed individuals (such as bus drivers) whom the school or facility does not employ to perform a Clinical Laboratory Improvement Amendments (CLIA)-waived COVID-19 test or a PCR COVID-19 test in public and private schools, kindergarten-twelve (K-12) grades?

No. The school RN cannot delegate COVID-19 testing to a non-credentialed individual who is not a staff member (such as a bus driver) to perform a CLIA-waived test.

Category: Corona Virus-19 (COVID-19) Testing

Registered Nurse (RN) Delegation of COVID-19 Testing – General Delegation

Can the registered nurse (RN) delegate to credentialed or non-credentialed staff, such as the nursing assistant, home care aide, medical assistant, or non-credentialed staff to perform population-based (pooled) Clinical Laboratory Improvement Amendments (CLIA)-waived or PCR COVID-19 tests without the RN assessingeach person?

No. The delegation process requires the RN to assess the patient before delegating tasks to the UAP and provide instructions to the UAP to perform the task. This process may be done using a routine screening form specific to COVID-19 and testing that does not require nursing judgment with instructions onwhen to notify the RN based on specific responses or questions/clarifications.

Does the registered nurse (RN) delegator need to be on the premises when credentialed or non-credentialed staff perform Clinical Laboratory Improvement Amendments (CLIA)-waived tests or polymerase chain reaction (PCR) COVID-19 tests?

No. The RN delegator does not need to be on the premises when credentialed or non-credentialed staff perform CLIA-waived or PCR COVID-19 tests. The RN must be available to answer questions or provide additional instructions as needed.

What is the RN's responsibility for reporting positive COVID-19 tests?

The RN is responsible for following the employer/facility processes in reporting positive COVID-19 tests. If the RN owns the business/facility, then the RN who owns the business/facility mustreport positive COVID-19 test results. w:

Is the registered nurse (RN) required to have a Medical Test Site (MTS) certification to perform Clinical Laboratory Improvement Amendments (CLIA)-waived or polymerase chain reaction (PCR) COVID-19 tests?

It depends. MTS Certification is required by the employer/facility to perform CLIA-waived tests regardless of setting. If the RN iownsof the business/facility, then the business/facility is must have the appropriate Medical Test Site certification.

Is the registered nurse (RN) required to document COVID-19 testing activities?

Yes. The RN mustdocument the care provided, including COVID-19 testing activities, regardless of the setting. Documentation can be done electronically or on paper using a patient's medical record. The RN should follow the employer/facility documentation policies and procedures. Standardized screening forms that include the results may be used for documentation. Documentation of positive tests must be reported to the Washington State Department of Health.

Can the registered nurse (RN) delegate to non-credentialed staff in a juvenile detention center to perform Clinical Laboratory Improvement Amendments (CLIA)-waived COVID-19 tests or polymerase chain reaction (PCR) COVID-19 tests?

No. The laws and rules only allow the RN to delegate to non-credentialed staff in public and private schools. In juvenile detension centers, the RN can delegate COVID-19 testing to the nursing assistant-registered/nursing-assistant-certified (NA-R/NA-C). An option may be to have specific staff obtain the NA-R or NA-C credential.

Can the registered nurse (RN) delegate to non-credentialed staff in a juvenile detention center that provides K-12 basic education services to juvenilesto perform Clinical Laboratory Improvement Amendments (CLIA)-waived COVID-19 tests or polymerase chain reaction (PCR) COVID-19 tests?

Yes. The RN is allowed to delegate COVID-19 testing to non-credentialed staff in schools provided through the Institutional Education Program/Office of Superintendents of Public Instruction (OSPI).

Institutional Education (ospi.k12.wa.us)

The RN must follow the delegation process outlined in RCW 18.79.260 (3)(a) to make that determination.

What are the recommendations if a business or facility does not have a registered nurse to delegate to staff?

Some businesses or facilities will not have an RN available to delegate to staff and may not have credentialed staff available. For businesses/facilities without an RN, options may be to offer take-home COVID-19 rapid antigen tests or have the patient self-test on site. Organizations should consider identifying an alternative mechanism and source of authority to conduct COVID-19 testing. This process is outside the Washington State Board of Nursing (WABON) authority. WABON recommends that business or facility consult with their legal counsel.

Can the registered nurse (RN) delegate to non-credentialed staff in a daycare, Head Start, or preschool to perform Clinical Laboratory Improvement Amendments (CLIA)-waived COVID-19 testing?

No. The RN cannot delegate tasks, like COVID-19 testing to non-credentialed staff in a daycare, head start, or preschool. The laws and rules regarding daycares, Head Starts, and preschools permit the parent or legal guardian to consent to provide health care. This permission is known as loco parentis (in place of the parent) and allows these settings to designate staff to act in place of a parent or legal guardian. This also allows the staff to test without an order or standing order from an authorized healthcare practitioner. The RN may be involved in training staff and providing consultation and guidance regarding the testing. The daycare, Head Start, or preschool musthave the Medical Test Site Certification. If a parent or legal guardian does the testing, the site would not be required to have the MTS Certification. The Washington State Board of Nursing (WABON) recommends that early childhood program consult with the Department of Children, Youth, and Families (DCYF) and their legal counsel.

WABON gets frequent questions about the school nurse accompanying a student on an out-of-state field trip or delegating to non-credentialed school staff who accompany a student on an out-of-state field trip.

- For states that are not in the NLC, or for a Washington State licensed nurse who does not have a multistate license, the
 WABON recommends the school nurse contact the state to determine if the school nurse can provide care to a student or
 delegate to non-credentialed or credentialed staff to provide care to a student while in that state without a license in that
 state. The WABON strongly encourages nurses who accompany students on field trips to other states that are in the NLC to
 have a multistate license.
- If the state is a member of the NLC, checking with the state is still applicable for a nurse with a multi-state license to determine if the school nurse can delegate tasks to a non-credentialed or credentialed person in another state. The laws applicable will always be those where the student is located.

Washington, DC Washington, DC Board of Nursing	As a professional courtesy, the District of Columbia (DC) Board of Nursing does not require nurses providing care in the District for a brief period (60 days) to be licensed in the District. Licensed nurses are subject to the same practice standards as in the state they are currently licensed in. The DC Board of Nursing does not dictate how the school district functions with regards to medication administration to children by unlicensed personnel while on out-of-state trips and should follow the state's regulations.
