- Ajay Mendoza gave an update on the Aesthetics webpage; interdisciplinary groups are working together to finalize recommendations and resources, once complete WABON staff will create a new webpage on its site to house the information for practicing nurses.
- Mary Sue Gorski gave an update on the telehealth advisory opinion put out by the Advanced Practice group, and clarified the temporary care outlined in RCW 18.134.050 for out-state-providers.
- Mary Sue Gorski gave an update on HELMS licensing demographic data, and the continued work to implement HELMS for survey and reporting on nurses.

Jessilyn Dagum gave an update about the ARNP Rules update, Phase Two. She shared information on the approved rules for review by the Board, section 246-840-300 → 4990 which includes 16 Advanced Practice rules and 28 Pain Management rules. The CR101 is expected to be filed in early summer.
